- c) The two persons are each a director, trustee, officer or greater than 10% owner in the same business or investment entity.

A "business relationship" does <u>not</u> include a relationship between (1) attorney and client, (2) medical professional (including psychologist) and patient, or (3) priest/clergy and penitent/communicant.
