2. Income Statement

- a. Net Income for the first three quarters was \$13K versus a budgeted loss of \$278K.
- b. The main variance in actual versus budget is the budget did not include any Grants, which were \$372K for this period.
- c. Additionally, Individual Contributions are \$81K over budget, partially offset by Foundation Contributions being \$56K under budget.
- d. Excluding the impact of Grants, Net Income is ~\$81K below budget driven primarily by Personnel Expenses being \$109K over budget, partially offset by Building Expenses being \$58K under budget.
